# DO QUALIFY FOR THE GREAT ESCAPE+!



In life's list of *do's* and *don'ts*, 4Life's Great Escape+ trip should definitely be something you do! This trip is a wonderful incentive to help motivate you to reach your business-building potential. Recently, we expanded the qualification options to give 4Life® distributors even more opportunities to qualify.

## **Are there other ways to qualify for a Great Escape+ trip?**

Distributors can also win a Great Escape+ trip by being eligible for the Power Pool drawing. 4Life selects a small group of active distributors to participate in this way.

## **How do I know if I have won a Great Escape+ trip?**

Once you qualify for a trip, a representative from the 4Life Events department will contact you via email with more details. For this reason, it is important to have a valid email address on file with 4Life. Then, a representative will contact you by phone and you will also receive a postcard in the mail.

## **How long do I have to redeem my trip?**

Because trips take place every six months, please redeem your trip at the earliest opportunity. If special circumstances arise, the 4Life Events department will work with you to redeem your trip at a later date.

## **Can I transfer my trip to someone else or redeem my trip for cash?**

4Life incentive trips are non-transferrable and are not redeemable for cash.

## **What is included on a Great Escape+ trip?**

Each trip includes unique excursions, activities, and benefits to make your experience spectacular. 4Life will provide all the necessary transportation for the qualified distributor and one guest, including flights to the destination, transportation to the events, and transportation to and from the airport at the destination. We encourage you to bring some additional money to cover potential meal or travel expenses.
